6. Public Presentations/Petitions/Delegations

6.1 Englobe presentation - Main Street Project 2024

Chris Gallant of Englobe presents details of the latest phase in the revitalization of Main Street in Shediac. The project is scheduled to take place from April to November 2024. This part of the project will cover the section from Foch Bridge to Chesley Street, including work on Dock Street. The main objective is to work in phases, and above all to ensure two-lane traffic throughout the project. Moreover, this plan cannot be modified by the companies that will be contracted. Pedestrian access will be maintained throughout the project, and the planned phases have also

been designed to ensure the smooth running of summer events and tourist visits.

Councillor Roland Cormier wonders whether the upgrades could have a positive impact on the residents of Sébastien Street, who often have to contend with very high water levels in the street. Mr. Gallant says that these are two unrelated issues, but that a solution is being developed for Sébastien Street.

Councillor Harry McInroy suggests changing the signage on the highway to indicate that there are two exits for Shediac. CAO Victor Boudreau points out that these are two different highways, so it's not possible to modify the signage at this point. Mr. McInroy suggests temporary signage. Mr. Boudreau also points out that Shediac's downtown business community naturally prefers to keep the same signage to welcome potential customers downtown.

6.2 Town of Shediac tourism sector update

Mélodie Martin, Tourism Development Officer with the Town of Shediac presents an update on the municipality's tourism sector to the municipal council. The economic development and tourism team is looking to make the best use of budgeted funds to position the municipality in potential regions that could attract tourists. The desired approach is to position the municipality more effectively using new technologies and influencers to promote Shediac as a destination of choice. Most regions and municipalities are adapting to new technologies and moving away from traditional trade shows. Shediac wants to do the same. In addition, communication tools such as the website will be updated. The strategy will focus on outdoor activities, gastronomy, arts and culture, special events and our must-see attractions. In closing, Mrs. Martin adds that the tourism accommodation levy is still under development, and that Council members will soon be able to review a new municipal by-law on the subject.

Councillor Paul Boudreau asked whether the municipality would continue to work with the Côte culturelle et touristique du Nouveau-Brunswick and Destination Sud-Est. Danny Pellerin, Director of Economic Development and Tourism, says yes, but the main issue is to make sure we don't waste resources, so it's a question of targeting our campaigns. Councillor Boudreau says it would be important to think about sports marketing. Mr. Pellerin points out that sporting events will also be part of our future strategies.

9. Report from the Chief Administrative Officer

Mr. Boudreau presents his report. He begins by pointing out that the major garbage collections will take place in the spring during the week of April 29 to May 2, 2024, and in the fall from September 30 to October 3, 2024. He is also pleased to inform Councillor Patricia Bourque-Chevarie that the transfer of land on Christian Court is now complete. Mr. Boudreau thanks the councillors who took part in the meeting with the Charlottetown delegation at the end of February. The meeting enabled us to learn more about this municipality's processes. The Town of Shediac also held an information meeting with Bellevue Street residents about a street reconstruction project that will take place from spring to fall. The CAO also notes that he has had several meetings at the regional level regarding the collection of blue bags for recycling. The changes will be minimal for residents, but behind the scenes, the service will be offered by ECO360 starting next November, so the municipal council will have to consider a few motions over the next few months on this subject.

Regarding the Main Street project, Councillor Murray Lloyd asks if it's not too late now to issue calls for proposals. Victor Boudreau says no, it's a good time. Chris Gallant of Englobe agrees, and points out that major companies are waiting for the call for proposals to go out, so he expects the project to be very competitive.

Councillor Peter Breau wishes to congratulate Julie Bélanger's team and the other departments on a wonderful evening on February 29. He points out that Mother Nature didn't want to cooperate, but the lighting effects were fantastic. Julie Bélanger points out that congratulations should go above all to Mélodie Martin, who really orchestrated the evening's festivities.

Councillor Jean-Claude Bertin asked if steps had been taken to invite Mr. Amédie Boucher to come and give a presentation to the Council to share his knowledge of pesticide use, as suggested by Councillor Peter Breau. Victor Boudreau explains that the administration was waiting for the creation of the environmental committee before taking any steps, but Mr. Boucher could be among the first to be invited.

Councillor Paul Boudreau asked Julie Bélanger if the lights used at the February 29 event belonged to the town, or if they were rented. He thinks it's really beautiful and gives a nice effect to the downtown area. Ms. Bélanger explains that the city is evaluating the possibility of purchasing them, but that costs, maintenance and other factors must be assessed. He would also like to know the status of the call for proposals for the Barracks. Victor Boudreau says the documents should be ready soon, and the call for proposals will be active. Regarding the Main Street project, Councillor Boudreau asked when the proposals would be presented to Council. Chris Gallant of Englobe indicates that in about 5 weeks, everything should be completed. Dany Boucher, civil engineer and sustainable development officer with the Town of Shediac, explains that the administration is trying to present the documents to Council at the April 15, 2024, meeting.

The second project is an addition to the Barracks project. It involves water lines that need to be relocated to continue development of the land where the new extension will be placed.

BE IT FURTHER RESOLVED THAT the Treasurer be authorized, in the name and on behalf of the Town of Shediac, to negotiate interim funding for the General Capital Fund according to the authorizations issued by the New Brunswick Municipal Finance Corporation.

15.3 New Sidewalks - 2024

Victor Boudreau reports that, following projects that were put on hold last year, the Municipal Operations and Engineering team has identified areas in the city where sidewalks could be developed.

Dany Boucher explains that the selection of this sidewalk project is based on an existing plan to eventually link Webster Street and Riverside Drive to Main Street. The work currently proposed allows pedestrians to access the municipal park located on the corner of Webster Street and LeBlanc Avenue. In addition, the portion on Sackville Street will provide a link between the municipal pathway near Highway 15 and the sidewalk network on Sackville and Breaux-Bridge Streets. Also, the strategy for selecting sidewalk projects will be based on the plan to be established in the Master Transportation Plan for the Town of Shediac, which is scheduled to be updated this year.

WHEREAS work on new sidewalks in 2023 on Webster Street (between Chesley and LeBlanc) could not be carried out last year due to delays with land acquisitions;

WHEREAS the administration has identified a potential section of new sidewalks on Sackville Street (between Breaux-Bridge and Landry) where a link between the municipal pathway and the existing sidewalk network is lacking, and where the existing City right-of-way is wide enough to allow installation without land acquisition, and for which the cost estimate falls within the allocated budget;

THEREFORE BE IT RESOLVED TO proceed with a new section of sidewalks on the north side of Webster Street from Chesley Street to LeBlanc Avenue, as well as a new section of sidewalks on the east side of Sackville Street between Breaux-Bridge Street and Landry Street. The estimated value of this work is \$449,740.30, including engineering and net

HST. It should be noted that a portion for a hydrant relocation and replacement of a portion of water line on Webster (total estimated value \$54,562.00 net HST included) will be drawn from the water fund. The remainder (an estimated value of \$395,178.30 net HST included) will come from account 1-28291 Special Projects - New Sidewalks.

BE IT FURTHER RESOLVED that Mentra Consultants Ltd. be awarded the engineering contract in the amount of \$51,941.40 net, including HST.

15.4 Award of Contract – Purchase of (2) ½ ton trucks

Dany Boucher explains that requests for bids were issued on February 8, 2024, for the purchase of trucks, and the bids were opened on February 29, 2024, at 2pm. Two bids were submitted. One of the new trucks will be assigned to the Public Works Department fleet and the other to the Recreation Department fleet.

The budget for this is account 1-28278 Special Projects - ½ ton truck in the amount of \$130,000.00. The balance of the funds will be used to add the accessories needed to put the two trucks into service.
